- The Co-Op: Oomingmak, Musk Ox Producers' Co-Operative is owned by the approximately 200 Native Alaskan women who do the hand knitting of all the items sold. By knitting with the Qiviut the members are able to earn a supplemental income to their mostly subsistence lifestyle. The majority of the members live in the isolated remote villages of Alaska. All active members also share in the profit at the end of the year.
- First Order: Minimum First Order is **Ten Items. Cash payment with first order is required.** Submit three credit references, a description of your store, list of items you carry. No discounts allowed with first order.
- Re-Order Minimum: Minimum Re-order **Six Items.**
- Terms: After first order net 30 days with approval of credit. Interest will be charged at an annual rate of 15% on late payments, over 30 days.
International orders must be paid in full by a Letter of Credit or other agreement.
- Pattern choices: PLEASE NOTE THAT PATTERNS MAY BE SUBSTITUTED AS NEED.
If substitutions are not acceptable, please let us know. Unavailable items will be omitted from the order. Please note the minimum order requirement must still be met.
- Exchanges: Exchanges can only be made with prior agreement. We do not accept items for exchange after one year.
- Postage and Handling Charges:
US: \$25.00 FOR ORDERS UNDER \$1000.00
2.5% of order value thereafter.
International orders will be charged an additional postage and handling fee:
5% of order value for Canada and Mexico.
10% of order value for all other countries.
